

# ARTICLES OF INCORPORATION NON-PROFIT COMPANY

#### Schedule A Item 4

#### TRINITY DOMUS COMMUNITIES



Restrictions on the undertaking that the Company may carry on:

The undertaking of the Company is restricted to fulfilling the following objects:

- To procure and manage financial, physical and human resources for the purpose of providing relief services in the most impoverished regions of Trinidad and Tobago to needy children (hereinafter called "assisted people") related to their physical needs, educational advancement, spiritual development, psychological health and social welfare.
- 2. To provide welfare and developmental services to assisted people in the selected regions through a network of volunteer community groups which it will help to maintain through financial support and governance.
- 3. To collaborate with local and international bodies of similar purpose and beliefs to relieve the effects of poverty among assisted people through developmental programmes and also through projects which provide temporary accommodation for emotionally and/or physically deprived children who are in urgent need of shelter, food and care.
- 4. To foster public awareness and understanding of social problems, economic impact and inter-generational issues related with the sustenance and human development of the assisted people and to advocate for remedial action and solutions to problems.
- 5. To take such steps by way of functions, dinners, social events and by personal or written appeals, public meetings, through the use of all types of media, that may from time to time be deemed expedient for the purpose of attaining the objectives of the Company.
- 6. To take additional steps for procuring contributions to the funds of the Company in the shape of annual contributions, donations (whether of real or personal estate), charitable grants, deeds of covenant, devises, bequests, pledges or otherwise and to authorize any person or persons within the Company to raise and collect funds whether through investments or otherwise on behalf of the Company.



To undertake and execute any trusts or any agency business which may seem directly 7. conducive to any of the objectives of the Company.

To undertake and carry on the office and duties of Trustees and Administrators of the 8.

Company.

To provide, endow, furnish and fit out with all necessary furniture and other equipment, 9. and maintain and manage such buildings and other premises as may from time to time be

required for the purposes of the Company.

To raise money for any of the above purposes by mortgaging or charging all or any such 10. property as may legally be mortgaged or charged with capital sums or with terminable

annuities for lives or years.

To invest the monies of the Company not immediately required for its purposes in or 11. upon such investments, securities or property as may be thought fit, subject nevertheless to such conditions (if any) as may be for time being so imposed or required by law and

subject also as hereinafter provided.

To do all such other things as are incidental or conducive to the attainment of the above 12.

objects or any of them.

To print and publish any newspapers, periodicals, books or leaflets that the Company 13.

may think desirable for the promotion of its objects.

To support any charitable associations or institutions approved by the President of 14. Trinidad and Tobago and to subscribe or guarantee money for charitable purposes in any

way connected with the purposes of the Company or calculated to further its objectives.

To purchase or otherwise acquire and undertake all or any part of the property, assets, REGISTERED liabilities and engagements of any one or more of the companies, institutions, societies, or associations with which the Company is authorized to amalgamate.

#### Other Provisions:

- 1. The number of members with which the Company is proposed to be registered is one hundred (100).
- 2. The income and property of the Company, whensoever derived shall be applied solely towards the promotion of the objects of the Company, and no portion thereof shall be paid or transferred directly or indirectly, by way of dividend, bonus or otherwise howsoever by way of profit to members of the Company.
- 3. The interest of each member in the Company is transferable.
- 4. The members of the Company may at any time resolve to wind up the Company, whereupon the assets of the Company, after payment of all debts and liabilities of the Company, shall be distributed.
- 5. Each member of the Company undertakes to contribute to the assets of the Company in the event of the same being wound up during the time that he is a member, or within one year afterwards for payment of the debts and liabilities of the Company contracted before the time at which he ceased to be a member, and of the costs, charges and expenses of winding up of same, and for the adjustments of the rights of the contributories amongst themselves, such amount as may be required not exceeding twenty-five dollars Trinidad and Tobago currency (\$25.00).
- 6. Should the profits of the Company be exempt from corporation tax under section 6
  (i) of the Corporation Tax Act, Chapter 75:02, upon its dissolution there shall be, after satisfaction of all its debts and liabilities, given or transferred any remaining property to such other non-profit company enjoying a similar exemption, as the members may, with the approval of the Board of Inland Revenue, determine.
